Mr. Jim Dvorak, President of the Geauga Township Association was present and handed out the four year meeting plan. Newbury Township will be hosting the next meeting on January 29, 2014 at 7:00PM. Ms. Blair also reported on the flood insurance. The cost and the deductible were expensive and the Trustee's decide not to purchase it.

Mr. Skomrock reported that the Special Olympics wanted to put a clothing box by the recycling boxes. Motion was made by Mr. Skomrock to allow the box, 2nd by Ms. Blair and a unanimous affirmative vote by all.

Mr. Skomrock will be getting a quote from another contractor for the repair work at the American Legion.

The next meeting will be on December the 11th and the final meeting of the year will be December 30th.

Mr. Quigley told Mr. Fagan that we would like to have a meeting again with the Fire Department Board on the soft billing. Mr. Fagan will get back to us with a date.

Mr. Quigley spoke on the progress of the Veterans Park.
