There is one neighbor that has a yard filled with junk cars, boats and other items. Mr. Gliha told the Whitewood residents at a prior meeting, that it is up to Trustees to do the best they can with junk vehicles. This neighbor has had a mess for over 20 years. Ms. Blair reported on the house that had a fire, the owner has received her check from the insurance company. She is checking to see if Troy Fire Department will burn it down for her. Ms. Blair reported that the repairs to the salt shed will begin on Monday April 20, 2015.

Mr. Quigley reported on the Veterans Park, there was a problem with the compression ring. The columns and compression ring will be made by Engineer Endeavors after the final plans have been approved.

Mr. Stefancin reported that they had marked where the 18 trees for the Eagle Scout project would be planted in Oberland Park.

Mr. Quigley reported that they are discussing a corn maize on the park land. He would get the cost of the seed back when he sold entrance fees to the maze. The Township would have to front the money for the seed and then it would be repaid by the entrance fee. Heather Fenstermaker was nominated as a new member of the Park Board. Ms. Blair made a motion to appoint Ms. Fenstermaker to the Park Board, 2nd by Mr. Quigley and a unanimous affirmative vote by all.
