This amount would be added to the property tax if it was not paid by Roberta Ann. Resolution 20170517-02 allowing the prosecutor to initiate cleanup of this property was made by Mr. Skomrock, 2nd by Ms. Blair and a unanimous affirmative vote by all.

Ms. Mansfield requested that the regular minutes from May 3, 2017, be approved as presented. Motion to accept the minutes as presented was made by Mr. Skomrock, 2nd by Ms. Blair and a unanimous affirmative vote by all.

Ms. Mansfield requested that resolution 20170517-01 be approved for the 2nd Half Advance of Real Estate Taxes, for all funds. Motion to approve resolution was made by Mr. Skomrock, 2nd by Ms. Blair and a unanimous affirmative vote by all.

Ms. Mansfield requested that the financials for April 2017 be approved; motion to approve the financials was made by Ms. Blair 2nd by Mr. Skomrock and a unanimous affirmative vote by all.

The trustees then discussed the employee manual. Sections 3.5 through the end were covered. Changes were made and the final will be approved at a future date
