The special meeting of Newbury Township Trustees was called to order at 7:00 PM, January 25, 2018, with Bill Skomrock and Greg Tropf present.

Before we get to Township business Mr. Skomrock was requested by Mr. Quigley to read the following statement:

A resident just threatened to "throat punch "me. I consider this action to be both credible and possibility life ending.

As a 14-year elected official, I know that on occasion people will disagree but until today I have never felt that a difference of opinion could lead to an injury or my death.

This last Wednesday I contacted the Geauga County Sherriff's Office and I'm now in the process of finalizing my official incident report. I've been informed by the investigating deputy that the perpetrator has been interviewed and she did not deny her guilt. My expectation is that any persons(s) involved in this despicable behavior will be prosecuted.

I've been advised that until the legal system can deal with this threat it would be prudent for me not to attend upcoming Township Meetings.

Shame to those that subscribe to and support the idea that violence is an acceptable form of civil discourse.
