

RECORD OF PROCEEDINGS

The regular meeting of the Board of Trustees of Newbury Township was called to order at 7:00 p.m., September 21, 2022 at the Newbury Township town hall. Chairman Bill Skomrock, Trustee Glen Quigley and Trustee Greg Tropf were in attendance.

Mr. Skomrock opened meeting with the Pledge of Allegiance.

Fire Department Update: 500 calls year to date.

Road Update:

Mr. Zimperman would like to re-run employment advertisement. He asked if the trustees would offer CDL training for a good applicant. Trustees said that they would be open to paying for training if they could be sure of recouping the costs by the employee staying with the township for a period of time to warrant the cost.

Fiscal Officer:

Fiscal officer presented minutes from the July 20, 2022 and August 3, 2022 regular meetings. Mr. Quigley moved to approve. Mr. Tropf seconded the motion.

Voice vote:

Geauga County Township Association is have Quarterly dinner meeting. Fiscal officer asked if any of the trustees would like to attend at a cost of \$25.00 per attendee. No trustees wished to attend.

Mr. Quigley update:

Camping prohibition: He believes that it would be easier to allow and control where and when camping would be permitted, than completely prohibiting. He proposed requiring a permit to camp in designated areas only. No motor homes would be allowed. He will look into definition of primitive camping.

NOPEC is discontinuing participation until rates stabilize.

On September 30th, Windstream will give a presentation at the pavilion at Oberland Park regarding upgrade to fiber optic cable.
