Mr. Skomrock opened the meeting with the Pledge of Allegiance.

Fire Department Update:

- Mr. Fagan shared that the Fire Department obtained two proposals for landscaping around the new building. He asked for a brick layout around the flag pole, both companies included in their quotes. Both said they couldn't start for a couple months. We do need to ask about warranty (plant guarantee, etc.).
 - H&M Landscaping proposal according to them, better to not put as many beds and mulch, a lot of upkeep, etc.
 - Impullitti Landscaping Inc. proposal beds all the way around, \$30k more expensive (\$82,503.20).
 - Mr. Tropf motioned to approve up to \$53,900 with H&M Landscaping with the caveat that we check their warranty. Mr. Lair seconded.

- The department has been getting employment applications started looking at them last week and will start interviewing soon. They have maybe received 15 so far only via word of mouth and posted posters. Paychex will help with a listing on indeed.com.
