

A regular meeting of Newbury Township Trustees called to order at 7:00 p.m., September 15, 2021, with Bill Skomrock and Greg Trof in attendance at the town hall

Mr. Skomrock opened the meeting with the Pledge of Allegiance.

Mr. Fagan reported that they would be having an open house on Sunday, September 26th, from 2:00 to 4:00.

NOPEC Grant: Quote for emergency generator was received. Adding an extended warranty was discussed. Due to nature of electronics, Trustees agreed on a ten year extended warranty. Cold weather add on was also added. Funds will be through NOPEC grant.

Glen Quigley drafted response letter to Mickey Cochran. Woodbury and Castlewood cannot be abandoned because of reduced access to other lots. Abandoning road would landlock lots and reduce access for Fire and Rescue vehicles.

Glen also drafted letter of thanks to Jeff Corrigan of Mangia Mangia for his continuing support for Newbury Community. Jeff provided meals for volunteers for car show.

Mr. Zimperman wanted to request hiring a full time road employee. Part time hires tend to come and go. Mr. Skomrock asked if he had anyone in mind. He asked Mr. Zimperman to keep them informed if he finds someone.
