

The regularly scheduled meeting of Newbury Township Trustees was called to order at 7:00 PM, October 17, 2018, with Bill Skomrock and Greg Tropf present.

Mr. Skomrock reported that there was progress at the Roberta Ann property, and it is now being cleaned up.

Mr. Fagan reported they will be going into 3 communities for Halloween on the 31st, Kiwanis Lake 5:30-6:00, Scranton Woods 6:15 – 6:45 and Kimberly estates 7-7:30 PM.

Ms. Drabek reported they are going to be doing a tree lighting this year. The Kiwanis club will be assisting with hot chocolate and cookies; the date is to be determined. Decorating of the park will be December 1 and 2.

Ms. Mansfield requested the approval of minutes from October 3, 2018. Motion to approve the minutes was made by Mr. Tropf 2nd by Mr. Skomrock and a unanimous affirmative vote by all.

Ms. Mansfield requested the approval of change order from Ronyak Paving for chip seal of various roads in the amount of \$3,378.30. Motion to approve change order was made by Mr. Skomrock no 2nd came due to Mr. Tropf's inability to vote on road contracts. Motion fails due to a lack of second. This will be revisited November 7, 2018.

Ms. Mansfield discussed a new D5 liquor permit for the address of 10760 Kinsman Road, Newbury, OH. It was then discussed if they should request a hearing or not.. Mr. Skomrock made a motion to not have a hearing 2nd by Mr. Tropf and a unanimous affirmative vote by all.

Ms. Mansfield requested the approval of September financials, motion by Mr. Skomrock 2nd by Mr. Tropf and a unanimous affirmative vote by all.

Mr. Tropf indicated Linda Applebaum gave her opinion on his participating in road discussions. She indicated that he should not be involved in bidding and awarding of bids. He may discuss in general roads and budgets.

Mr. Skomrock indicated he is waiting for a little more information on the grant for the LED street lights. He also discussed nuisance property meeting held by the county, and how the townships are on the hook for the bills to clean them up.
