Kelly Wanyak from Ravenna Road asked about a facebook post that Mr. Yeager posted regarding the Newbury Schools and what would happened to them if the school was to consolidate. The trustees indicated that there have been no official talks between the school and the township as of today.

Mr. Quigley requested that Mr. Zimperman take down the American Flag at Vets Park, until the light can be fixed.

Mr. Tropf is working on the credit card policy.

Mr. Tomsic asked about the zoning administrative specialist and the BZA secretary. Mr. Quigley indicated they are still accepting applications and will let them know when they are ready to make a decision.

Mr. Quigley asked for a motion to appoint Mr. Tomsic as a BZA member for another 5 year term. Motion by Mr. Skomrock, 2nd by Mr. Tropf and a unanimous affirmative vote by all.

Mr. Quigley discussed the grant for the Oberland Park porta potty. He has been informed that the grant he was applying for is not able to be used for this purpose. He will look for other grants that will allow this type of expenditure. He asked if the board would be will to give approximately \$12,500 to this project as a match for a grant. The other Trustees indicated they would bel will if a grant is found.

Mr. Skomrock reported for the sheriffs department 182 calls in December. Sunrise Springs contacted him regarding a purchase on Grange Park. It was reported the Kuhnle recently purchased property directly behind them for approximately \$17,000 to \$19,000 per acre. Mr. Tropf will do some more research on potential tax collection on a parcel this size in the industrial area.

Mr. Quigley reported numerous complaints on 11210 Kimmeridge Trail, he has contacted zoning to look into the problem. The township will be marking roads in this area as "no parking".

Mr. Quigley discussed a conditional use permit for Oberland Park because it is in a residential area. Mr. Quigley asked for a motion that the township waive the BZA fees on this application. Motion by Mr. Skomrock, 2nd by Mr. Tropf and a unanimous affirmative vote by all.

Mr. Skomrock discussed the old Ironman building and its current condition. Mr. Tropf thought that the best use is for storage, the area will need electrical work. If it is to be turned into offices a lot of work would be needed. They then discussed having someone come in and analyze the current buildings. Mr. Skomrock will work on having the buildings analyzed.
