Mr. Zimperman proposes to pave Peking Road in 25 and 26. He will be working with the Engineer's office to obtain OPOWC grant funds for that project.

He is also looking at a joint project with Munson Township for Cedar Road.

#### Mr. Quigley updates: Absent

#### Mr. Stefancin spoke on behalf of Park Board

Park Board will plant the trees used at the Gazebo to replace the one that is dying. They will mark location of benches so that service department can pour footers/bases as discussed at January 4<sup>th</sup> meeting.

Park Board will accept the used light poles that will be removed from the fire station as part of the renovation/addition construction. They are hoping that they can use part of the NOPEC grant to offset cost.

## Mr. Tropf's updates:

West Geauga Soccer would like to use the former football field. They stated that they are willing to do work and maintain field. Will work with Park Board.

Press Box windows are broken. Township needs to have bleachers and playground equipment inspected for safety.

The Fire Department should have their annual contract ready to review by February 15th. Will need to have a meeting to have all parties sign.

#### Mr. Skomrock's update:

Mr. Skomrock spoke with Shane at the Engineer's office. The township will not accept the work performed on Linda and Diane as it was not done to satisfaction. He will have Rachel Formica draft a letter to Geauga Highway.

Wendy French from OTARMA indicated that they would waive any additional premium with regard to the leased property from West Geauga Board of Education. They believe that the personal property that will be stored there is already covered under the present policy.

#### Other business:

Resident Cynthia Haubrich asked if the running track would be open for use by residents, now that the township has leased the former school property. It was explained that because the track had not been used and maintained for so many years, that the original cinder track was completely overgrown. It would be cost prohibitive to restore it. Mr. Skomrock did explain that there are waking trails on the existing Oberland park property and with the additional 30 plus acres there is more than enough room for activities.
