Fire Department Update:

Chief Fagan reported calls year to date were 202, with 28 calls so far in April.

Road Dept Update:

Mr. Zimperman reported that the crabapple trees at Munn Cemetery would be sprayed. Expects cost to be \$600.00

They have planted trees at the recycling site.

Fiscal Officer's Report

Ad was placed for special work session for the 2023 Tax budget for Saturday May 14, 2022 at 9:00 a.m.

Mr. Tropf's updates:

Mr. Tropf reported that there had been a cemetery deed missing with regard to family plots reserved at the time of the interment of Nessa Harmling's son Andy. Mr. Tropf reported that the sexton would prepare the deed and that the trustees could sign at the next meeting.

Mr. Quigley updates:

Mr. Quigley brought up the issue of exempting payment for pre-need purchase of cemetery plots. This was discussed previously as it related to Medicaid and Hospice circumstances. It will remain at the discretion of the trustees.

Mr. Quigley asked Doug to pick up flags for Memorial Day. Mr. Zimperman indicated that the issue had been previously discussed and taken care of.

Rudy Schwartz will mark boundary of Veterans park for placement of flag project. Park Board will purchase materials and supplies for installation of flag poles.

NOPEC will allow accumulation of grant funds and there will no longer need to be a specific project determined at the time of grant application.

Other Business:

Employee reviews will be discussed after the 2023 Tax Budget work session on May 14th.

Discussion of signs prohibiting engine brakes within the township. Enforcement has to be through the Sheriff's Office. Suggested that local businesses be individually contracted by letter to request cooperation.

Resident Jeff Munn spoke about the intermediated building. He wanted to know what the building would be used for if it was acquired by the township. He question the financial responsibility of the township. He presented mailings dated prior to the Newbury and West Geauga School Districts merger. He had questions about who sent which mailings. Mr. Skomrock spoke about his wishes to continue to use the auditorium for speakers prior to the Memorial Day parade. He stated that certain spaces would be leased to third party entities.
