Road Department Update:

Shane Hajjar forwarded documents to be executed by trustees for OPWC grant and loan applications to pave Pekin Road from Sperry to Bass Lake Road in 2024. With those funds from Ohio Public Works, additional paving can be placed on the schedule for 2024.

Mr. Tropf moved to have Schwartz Survey to mark boundaries of Munn Cemetery in In an amount not to exceed \$5,000.00. Mr. Skomrock seconded the motion.

Mr. Tropf suggested that with the OPWC funds reducing the township's expense on Pekin, that they should pick another mile of road for paving next year, Ask Shane Hajjar to estimate costs for additional roads.
