The regular meeting of the Board of Trustees of Newbury Township was called to order at 7:00 p.m. at the Newbury Township town hall. Vice Chairman Glen Quigley and Trustee Greg Tropf were in attendance. Chairman Bill Skomrock was absent.

Mr. Quigley opened the meeting with the Pledge of Allegiance.

Fire Department Update: The new contract for 2023 for the fire department is still at the Prosecutor's office. After they review, the contract will be signed at the March 2nd 2022 meeting.

Chief Fagan reported calls year to date were 73, with 19 calls so far in February.

Road Department Update:

Mr. Zimperman is still looking for verbiage for a no parking resolution.

Nick Gorris from the engineer's office contacted regarding paving for 2022. Doug needs to add drainage pipe for Burton Heights Blvd. He asked if there was enough money for tree work. Fiscal officer affirmed that funds were already budgeted up to \$20,000. Funds are also available for drainage at \$20,000. Doug asked if Lorraine Sevich could send letters to the residents. He has a draft of that letter. Trustees agreed that that was a good idea.

Doug asked about adding a federal holiday for Juneteenth. Trustees agreed that since it is a federal holiday, and the Township follows the federal holiday schedule they would add that as a holiday for the Township employees. A change to the personnel manual will have to be made to state all federal holidays

Cleanup day is scheduled for the first Saturday in June Mr Zimperman is working with the Department of Aging for senior pickup.

There's a streetlight request in Kiwanis lake for the bus stop. Mr Quigley suggested a 50 Watt light being it is a safety issue. Greg Tropf moved to go forward with that, motion was seconded by Glen Quigley

Voice vote: two ayes, one absent. Motion carried.

Park Board Update:

Flag project. Estimate of up to \$1200 for flags and \$2000 for polls. Mr. Quigley also wanted to include adding plants. Total estimate would be \$6500. No motion or action was taken. Oberland Park discussion of restroom facility Mr. Quigley is looking at a waterless restroom facility with an approximate cost of \$45,000 to \$60,000. Bev Sustar commented as resident, that if a facility was to be installed, she would prefer a full restroom with running water. Mr Quigley stated that he would prefer the waterless option and not going with a septic system due to maintenance and pumping costs Mr. Tropf suggested getting prices for a well and septic. Mr. Quigley suggested that he do that .

Jim Stefancin, with the park board, reported they would like to do a fall festival. They did check out the cost of a corn maze and it is cost prohibitive. He suggested another idea was for a pumpkin toss, possibly with a trebuchet. No action was taken. More information is needed.

Mr. Tropf spoke about the ARPA grant. Possible use is partnering with Windstream to upgrade internet infrastructure. Mr. Tropf has a meeting with the county to see if they would be interested in partnering with the Township on that upgrade.

The Geauga Trumbull Solid Waste District's scrap tire grant for 2022 has been increased to \$3220. Trustees will sign the DIG grant. Geauga Trumbull Solid Waste District anticipated opening the Geauga drop off site as soon as April of this year.

NOPEC grant for 2022: Doug suggested that the grant could be used to install a security light at Overland Park at the West End of the parking lot. General agreement. More information is required to estimate cost.
