#### Fire Department Update:

- There were 78 calls in September and three this month so far. 684 calls YTD.
  - Mr. Fagan handed in a request for the next new hire payment. The department hired 3 additional FT staff and 5 additional PT. One FT changed to PT.
- Trick-or-treating will be October 31<sup>st</sup> (Thursday) with the Fire Dept splitting time between Kiwanis Lake and Kimberly Estates 5:30-7:30pm.
  - o Ms. Pollock to email Kathy Shimer of Destination Geauga to inform.

#### **Road Department Update:**

- Pekin Rd paving project: close to complete (was projected Sept 28).
- Transformer from down utility pole has been removed by CEI.
- Planned mower replacement
  - Ferris factory rep should be coming out to assess status (presume totaled).
  - o Insurance appraiser coming 10/9 to evaluate from OTARMA.
  - o \$8,600-\$9,000 to replace (through Sourcewell) \$1,000 off during sale
  - Mr. Skomrock motioned to approve up to \$9,000 for purchase of a replacement mower. Mr. Lair seconded.
    - Voice vote: Three ayes.
- Mr. Zimperman and the Trustees discussed the potential upgrade on second utility truck, trading in regular cab truck.
  - Mr. Tropf would like to spend less, and also reduce the total number of trucks from 11 since the Township has a small staff.
  - Mr. Skomrock and Mr. Lair asked about cost difference for a 350 instead of 450/550.
- Turned in 2025 paving schedule to County Engineer's office.

- VSP (vision insurance provider) notified us that they will not raise rates for the next four vears.
- Ms. Pollock will be unable to attend the Nov 20<sup>th</sup> BOT meeting. Mr. Tropf's wife may be
  able to take notes for the minutes, but will ask Ruth Cavanagh (Zoning Secretary) to see
  if she is able.
- The arm of Ms. Pollock's office chair is coming apart, may order new chair, but for now will try to use one of the conference room chairs.
- Would like to plan Iron Mountain to come to the Town Hall early 2025 to remove / destroy files that are past their retention period.

### Jim Stefancin - Park Board

- Trustees and Mr. Stefancin discussed the seeding of an area at Oberland Park. Mr. Stefancin said the park board would take care of it, likely spending \$2000 or less.
  - Mr. Skomrock motioned to approve spending up to \$2,000 to seed Oberland Park and Mr. Lair seconded.
  - o Voice vote: three ayes.
- Concert and car show both well attended!

### Mr. Tropf's updates:

- Miller Dodson's Replacement Reserve Report FY2024 Mr. Tropf sent an email out to the Trustees to review with his comments, asking for feedback within next week or two.
- Zoning commission still reviewing allowing landscaping in commercial district
  - Next step is to finalize resolution, get to planning commission, will come to Trustees at some point.
- Mr. Tropf spoke with Les Ober who agreed to take all maple equipment out of the woods, return money to Timmons Farm for any bailing of hay and will pay \$600 to us for allowing him to use the field.
  - Todd Palevic would like to continue sugaring at the property, Mr. Lair said the board needs to discuss – lease options / verbiage, opening it to others, etc.
  - o Some areas had tubing across the paths, branches have come down on tubing.
  - Possibly inquire about cleaning up woods to make it safer Mr. Lair has a contact. Ohio State extension.
  - Ms. Pollock to send invoice to Les for \$600, confirming wording with Mr. Tropf.
  - Zoning Inspector, John Boksansky is good with Geauga Access, he could give details of area, acreage, etc.

#### Mr. Lair's Update:

- Go Green cameras are all installed at recycle bin total grant \$4,108.88, will be reimbursed \$3,735.35, out of pocket \$373.53.
- NOPEC Mr. Lair is working to apply \$11,473 for 2024 energize grant to be used against the generator purchased for the Town Hall.
- Cemetery Milano has started work on Newbury Center (goal is to finish by end of year)
- Meeting with Zirkle Tech tomorrow to do cameras at additional areas.

### Mr. Skomrock's Updates:

- Sheriff's report: 224 calls, traffic, Fire Dept, abandoned vehicles, welfare checks, etc.
- AED required by 10/24/24 playing fields, also emergency plan and staff training, compatible with Fire Dept equipment. Trustees will look into.
- Capital improvement grant paperwork
  - Chip Hess followed up to see about permits
  - Chagrin River Watershed Partnership asking for help with obtaining permits
  - o Green Flush payment 10% up front likely to be paid this year
- Mower / tractor received quote from John Deere for cab tractor, grappling hook, bucket \$71,670.99
  - Mr. Skomrock motioned to approve the purchase of the tractor as quoted and Mr. Lair seconded
  - o Voice vote: three ayes.
- Mr. Skomrock and Mr. Zimperman met with a candidate for a full-time road department job and both had good impression.
  - Mr. Skomrock motioned to give an offer of employment to Mike Varcelli and Mr. Lair seconded.
